# Attorney Padgett overview of Bond Discussion

- Updated terms on Wednesday
- Agreed to comprehensive review from great hearts, including building hope for previous analysis
- TCS must provide evidence of efforts to fix issues identified in Building Hope Review

- Also, agree to an Investor Call with an update on the progress with Building Hope on the status
- Bond Holders will allow TCS to use Great Hearts for a Management Consultant if they are not satisfied; they reserve the right to hire a management consultant Not willing to drop enrollment requirement as the default term
- They want a governing board consultant- a much more particular review
- Not willing to drop enrollment requirement as default term
- They will update forbearance agreement to remove automatic termination provisions
